



MS Society Edmonton 50/50 Raffle Rules

1. Raffle tickets shall not be sold to a person under 18 years of age.
2. Adults will be advised not to write the name of a person under 18 years of age on the ticket.
3. The Multiple Sclerosis Society of Canada Staff and Board Members are not eligible to purchase tickets for the raffle.
4. All ticket purchasers must be a resident of Alberta.
5. Tickets will be sold at 1 for \$5 and 40,000 tickets will be printed. A minimum of 5,000 tickets must be sold before the MS Society will request, from the AGLC, a draw date extension or to cancel the raffle.
6. Exact draw location: KiSS 91.7 Radio Station Studio, 5915 Gateway Boulevard, Edmonton, AB T6H 2H3 at 8:00am on May 31, 2019.
7. The draw will be conducted by all ticket stubs will be placed in a rolling barrel to select the winner. The barrel will be rolled multiple times to mix up the entries. One single ticket will be draw from the barrel.
8. It is a single percentage prize draw (50%) and therefore, only one ticket will be drawn to select the winner.
9. The winner of the percentage draw (50/50) will be contacted by both phone and email three (3) times (if necessary) to claim their prize. The prize will be guaranteed for one (1) year following the official draw. If after one (1) year, the winner has not claimed their prize, the prize amount will be donated to the Multiple Sclerosis Society of Canada – Edmonton Chapter office for use in another fundraising raffle.
10. Tickets will only be available for purchase in person. No online sales will be available.
11. The purchase of tickets will be promoted through the MS Society Edmonton Chapter social media channels (Twitter, Facebook and Instagram). It will also be promoted on the KiSS 91.7 website, social media, and on-air by their radio hosts. A&W will promote the raffle through their website and social media channels.
12. The MS Society will ensure that KiSS 91.7 radio includes the following in all on air promotions:
 - a. The Multiple Sclerosis Society of Canada – Edmonton Chapter as the charity
 - b. The licence number for the raffle
 - c. The date and location of the raffle draw
 - d. Statement that tickets may only be purchased or sold within Alberta
13. The MS Society will fully refund at the ticket price of \$5.00 to any persons who wishes to cancel their raffle ticket purchase. They will be required to provide their half of the ticket, which was issued as their receipt of purchase. Subsequently, their corresponding ticket stub will be removed from the stubs collected and no longer eligible for the draw.
14. The MS Society – Edmonton Chapter will also include the information that a winning ticket stub may have more than one name on the stub, however, the MS Society will only award the cheque to one of the individuals identified on the ticket. The MS Society – Edmonton Chapter and the AGLC will not be responsible for any disputes which may arise between the different individuals whose names appear on the ticket stubs.

Books of tickets will be kept by a dedicated group of individuals, not distributed amongst numerous volunteers for sale, and only sold in the above locations. Sales will be available during the office hours at the radio station for the duration of the raffle period.
22. Tickets are \$5.00 and will only be offered at the price point of 1 for \$5.00. The ticket stub with the corresponding number to the ticket stub retained by the raffle's organizations, will be used as the purchaser's official receipt.
23. Tracking will be done with the AGLC ticket sales tracking form to insure all tickets and stubs are accounted for.
